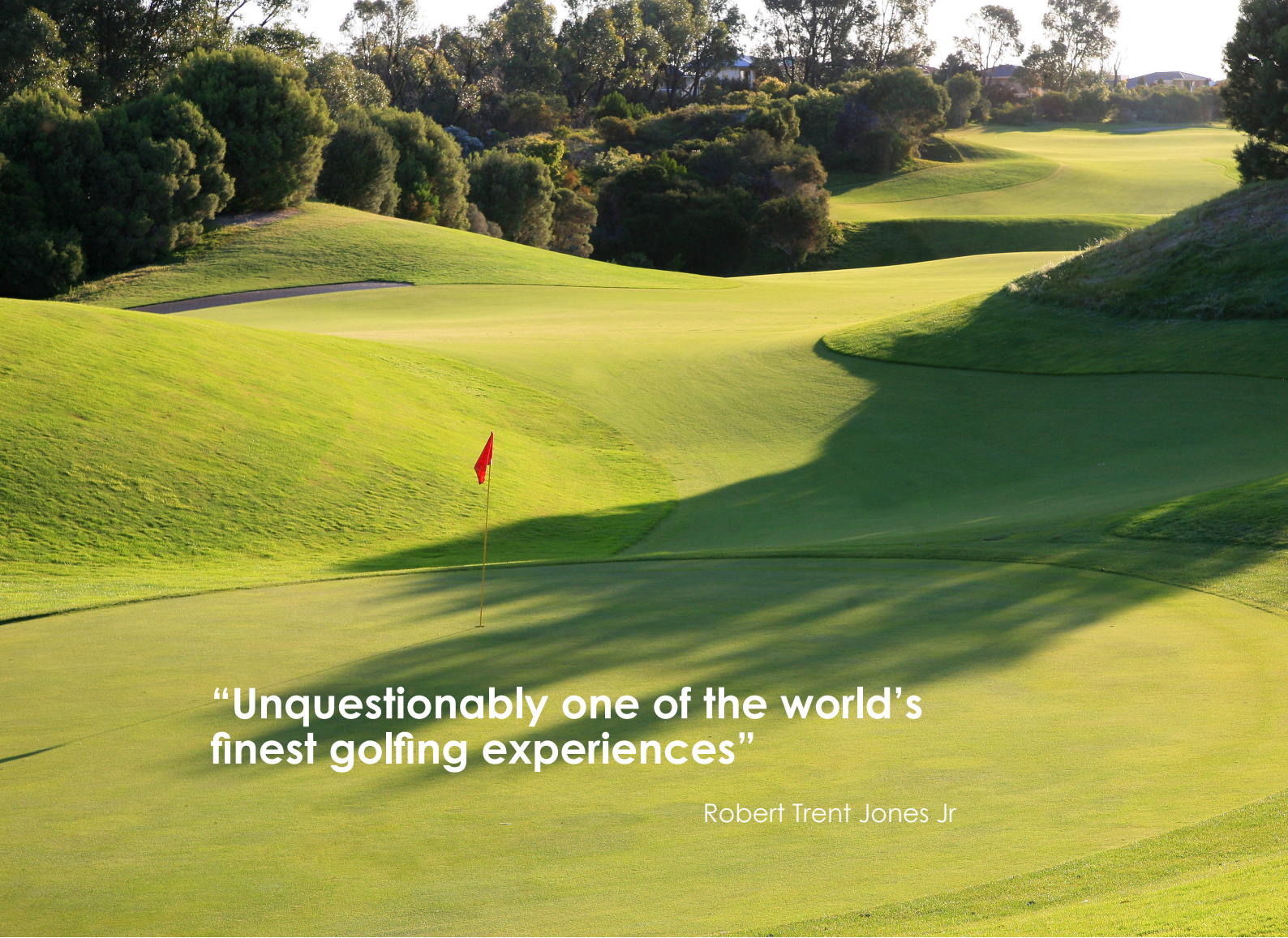

One minute you’re playing an approach shot beneath a 30-metre limestone cliff, the next you’re adapting to the fresh ocean breeze of an undulating links style fairway.

Enjoy your golf in a magnificent setting, with the natural beauty of the bush, ocean glimpses as well as the irresistible charm of kangaroos, birds and other wildlife.
